#### NAPNAP Partners ACT Advocates Campaign

Earlier this year, NAPNAP Partners launched its ACT Advocates program to provide grassroots training on child trafficking. ACT Advocates are healthcare providers who, after completing a specifically designed curriculum on trafficking, conduct education sessions for their peers at hospitals, clinics and primary care offices as well as local/state conferences and events. NAPNAP Partners trained its first class of 50 ACT Advocates at NAPNAP's national conference in March. Future ACT Advocate trainings are scheduled for the Emergency Nursing Association's (ENA's) national conference in September, the American Association of Nurse Practitioners' Fall Conference in October and the National Association of Pediatric Nurse Practitioners' (NAPNAP's) Leadership and Advocacy Forum in November. #### NAPNAP Partners' 3-PARRT Available

Healthcare providers are on the front lines to identify and help child trafficking victims but lack the essential knowledge and skills because it hasn't been taught in academic programs. To reduce the knowledge gap, NAPNAP Partners recently launched its CE /CME-accredited <u>3-PARRT (Providers Assessing Risk and Responding to Trafficking)</u> continuing education modules. The three-module, on-demand course is the first to focus on the pediatric population and prevention. We thank the American Academy of Pediatrics (AAP), National Association of School Nurses (NASN), Emergency Nurses Association (ENA) and others for their support and contributions to this course. NAPNAP Partners especially thanks: Dr. Elizabeth Hopper (HEAL Trafficking); Sarah Moultrie, MSN, CPNP-AC, CPEN (ENA); Linda Neumann, RN (NASN); Drs. ## The American Academy of Pediatrics Publications on Trafficking

- *Child Abuse: Medical Diagnosis and Management*, 4th ed, will include a new chapter on Human Trafficking and Sexual Exploitation via Electronic Media, covering both child sex trafficking and labor trafficking. It discusses recruitment and control tactics, screening and red flags, medical and mental health management, and referrals and resources (coming in September 2019).
- <u>Medical Evaluation of Child Sexual Abuse: A Practical Guide, 4th ed</u>, includes a new chapter on Child Sex Trafficking. (currently available).
- *Berkowitz's Pediatrics*, 6th ed, will have a new chapter on Commercially Exploited Children and Human Trafficking (coming in February 2020).

## **Shared Hope International Survey Request**

To support the innovative work of individuals and organizations combating human trafficking and to drive the next wave of smart and sustainable policy change, Shared Hope International is working towards the release of a new legislative framework in 2020 that will address some of the more nuanced and challenging issues related to sex trafficking. To assist with their efforts, they invite stakeholders to participate in a <u>10-</u><u>15-minute survey</u> to provide insight into the challenges and successes of implementing and enforcing laws related to child sex trafficking. Responses are requested by Sept. 16, 2019.

### **Delaware Hospitals Helping to Limit Human Trafficking**

The Delaware Healthcare Association announced its coordinated victim identification protocol, which has been adopted by all hospitals throughout the state. "We believe Delaware is the first state to advance a common human trafficking protocol on a statewide basis," its press release states. Each hospital in Delaware will work to implement the recommendations over the next year. DHA encourages other states to join in similar efforts to combat human trafficking.

## NHTTAC and OTIP Offering Important Resources in Spanish

The National Human Trafficking Training and Technical Assistance Center (NHTTAC) recently promoted its efforts to offer non-English language resources, including Spanish materials and trainings to support healthcare's response to human trafficking. The <u>SOAR to Health and Wellness Online</u> training is available in both English and Spanish. The Office on Trafficking in Persons (OTIP) offers a <u>variety of materials</u> in both English and Spanish to raise awareness and share the National Human Trafficking Hotline.
